Winter Checkup Program

Don't let your pool become a pond! Over the last few years many of our customers, especially those with mesh safety covers, have asked if there was something we could do to help their pools remain cleaner over the winter in preparation for spring opening, and also the importance of keeping the water level below the tile line.

We cannot stress the importance of this service for new pools and newly renovated pool finishes.

This is our third year offering the winter checkup program for our customers. Details outlined below:

Mesh Cover Pools:

1. Install chlorine floater to pool to add chlorine in a small amount throughout the winter.
2. A Service tech will come out to your pool twice, once in November and again in February/March (weather conditions may deter these times, such as excessive snow and freezing).
3. Test and adjust water chemistry.
4. Check and lower water level, if needed.

Solid Cover Pools (without water tubes/bags):

1. Same steps will be followed as with mesh cover pools except excess water will be pumped off solid covers (weather conditions may deter this process, such as excessive snow or freezing).

Rates:

- \$60.00 for first half hour; additional time billed at \$15.00 every 15 minutes thereafter. (*Pools more than 20 miles from Hellertown will have additional charges*)
- A fee of \$15.99 will be charged for each chlorine floater installed and it can be reused for a few years. Homeowner's chlorine tablets can be used in the floater or we will add tablets and bill the homeowner accordingly.
- **Please make sure your chemicals are accessible.** All chemicals supplied by BBCP used to balance water chemistry will be billed to the homeowner accordingly.

We believe that balancing water chemistry throughout the winter will help your pool not only extend plaster life, but also help with the condition of the water at opening time.
