B&B CUSTOM POOLS agrees to service your pool and/or spa on a weekly or bi-weekly basis as requested below. We will: vacuum your pool, brush walls, empty skimmers, backwash filter as needed, empty automatic cleaner bag if applicable, test pool water and add chemicals as needed (we will use customer's if they are available, otherwise you will be invoiced for any supplied by BBCP), and check all pool equipment. (Any repairs, labor, and parts will be billed at our standard service rates)

Maintenance Service Cost (please choose desired frequency below) \$85.00 per service call up to 1st hour

- Weekly Service Bi-Weekly Service Monthly Service (Indoor pools only)

Pre-Pay Season Special: Starting Monday, May 21st and ending Saturday, August 25th. To receive this contracted service, payment in full must be received by April 15th. This special only applies to the weeks designated herein. Early termination of this contracted service will result in no refunds. Service outside of designated weeks billed at standard rate.

- Weekly Service Special - 14 weeks \$1,050.00 Service Before/After Special weeks

- Bi-Weekly Service Special - 7 weeks \$525.00

\*If you select bi-weekly you will have to check skimmer baskets and test your water weekly, adding chemicals as needed.

Please note: Fuel charges will apply for locations over 20 miles from Hellertown. This service does not include major spring opening clean-up or excessive fall leaves. Throughout the season storms causing excessive debris and dirt in pool that requires more than an hour of clean-up will be billed @ \$15 each additional 1/4 hour.
